**The following forms and documents are required from each applicant, including children:**

- Photograph and Signature Certificate (Form C2)
- Medical Certificate (Form C3) including original results of HIV test (HIV test is required for all persons applying for citizenship including children). Note that the HIV test results must be not older than 3 months.
- Certified copy of your current passport(s) showing name, photo, citizenship/nationality, date and place of issue, expiry date, passport number and issuing country.
- Certified copy of your current national identity card(s)
- 6 original passport-size photos of yourself taken within the past 6 months. The photos must be
  - A full front close up view of the head and shoulders with the head covering 70% to 80% of the photograph
  - Without sunglasses. Tinted prescription glasses may be worn as long as eyes are still visible
  - Show you looking straight at the camera, your eyes open, no hair in your eyes and without any head covering
  - Be taken with a neutral expression (not laughing or frowning) with your mouth closed
  - A true image and not altered in any way, with a plain, light coloured background, clear, sharp and in focus
  - Approximately 35 x 45 mm in size, of good quality colour and on high quality paper
  - The photos must be the same in all aspects, and one of the photos must be certified and attached to form C2
- Original excerpt of full birth record or certified copy of full birth certificate (i.e. a birth document that also includes your parent's details, or a household register, family book etc.)
- Original police certificate(s) from country of citizenship (unless you can provide satisfactory evidence that you have never lived there) and from any country where you have lived more than 1 year over the past 10 years.
